**ORDER**

F.NRC/NCTE/F-7/6863-6878&7001, Dt:13.08.2006, (for B.Ed.) & F.NRC/NCTE/F-7/RJ-1222/2007/30103-30109, Dt:11.10.2007(M.ED).

And Whereas, Revised Recognition order was issued to **ICG INSTITUTE OF EDUCATIONAL RESEARCH & DEVELOPMENT, ICG CAMPUS, GURUKUL MARG, SFS, MANSAROVAR, JAIPUR, RAJASTHAN-302020** vide order no. F.No. NRC/NRC/NCTE/F-7/RJ-Common Orders/2015/115386, dated 09.06.2015 for B.Ed. & M.Ed of Two Year Duration with an annual intake of 100 seats (B.Ed)/50 seats (M.Ed) students (Two basic unit of 50 students each) from the academic session 2015-2016.

And Whereas, the Institution vide letter dt. 28.02.2018 submitted an application for shifting of premises from **ICG INSTITUTE OF EDUCATIONAL RESEARCH & DEVELOPMENT, ICG CAMPUS, GURUKUL MARG, SFS, MANSAROVAR, JAIPUR, RAJASTHAN-302020** to **ICG INSTITUTE OF EDUCATIONAL RESEARCH & DEVELOPMENT, ISI-11, RIICO INSTITUTIONAL AREA, SITAPURA, JAIPUR, RAJASTHAN-302022**.

And Whereas, The matter was placed before the NRC in its 294<sup>th</sup> meeting held on 28<sup>TH</sup> - 29<sup>TH</sup> JANUARY 2020. The Committee decided as under:-

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observation was made:-

1. VT be constituted for shifting of premises.

And Whereas, the matter was placed before the NRC in its 311<sup>TH</sup> meeting held on 16<sup>TH</sup> - 17<sup>TH</sup> JANUARY, 2020. The Committee decided as under:-



The institution has complied with all the requirements as per NCTE Regulations and WRC decided to permit the shifting from old premises **ICG INSTITUTE OF EDUCATIONAL RESEARCH & DEVELOPMENT, ICG CAMPUS, GURUKUL MARG, SFS, MANSAROVAR, JAIPUR, RAJASTHAN-302020** to new premises **ICG INSTITUTE OF EDUCATIONAL RESEARCH & DEVELOPMENT, ISI-11, RIICO INSTITUTIONAL AREA, SITAPURA, JAIPUR, RAJASTHAN-302022**.

Now therefore, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, Permission under clause 8(9) of NCTE regulation, 2014, is hereby granted for change of premises of **ICG INSTITUTE OF EDUCATIONAL RESEARCH & DEVELOPMENT, ICG CAMPUS, GURUKUL MARG, SFS, MANSAROVAR, JAIPUR, RAJASTHAN-302020** to **ICG INSTITUTE OF EDUCATIONAL RESEARCH & DEVELOPMENT, ISI-11, RIICO INSTITUTIONAL AREA, SITAPURA, JAIPUR, RAJASTHAN-302022**.


With immediate effect for conducting B.Ed/M.ED Course of two years duration with an annual intake of 100/50 students.
