NOTICE FOR POST RESULT DECLARATION FACILITIES FOR STUDENTS OF CLASS XII- PART-2

The Board feels that the OSM framework would help in bringing greater consistency, accuracy, and efficiency in the evaluation process.

The Board acknowledges that, notwithstanding the advantages of the system, certain concerns and representations have been received from anxious students and other stakeholders through various modes including social media handles, regarding the results declared and the OSM process itself. Taking cognizance of these concerns raised by students and in the interest of ensuring a student-friendly and responsive mechanism, CBSE has introduced structured post-result facilities with prescribed procedures.
